Clubhouses Offer a No Nonsense Approach to the Mental Health Crisis

Mental health Clubhouse programs are one of the most cost-effective solutions to the state's mental health crisis. They provide daily, ongoing support for people with severe mental illness at a fraction of the cost of hospitalization and incarceration.

Clubhouses help people with severe mental illnesses achieve stability and find work, improving financial self-sufficiency and decreasing dependency on governmental support.

Clubhouses provide:

- Daily activities during the “work-ordered day,” an 8-hour day, 5 days a week, that reflect a regular work day in the business world
- Voluntary and affordable membership for life
- Opportunities to utilize and increase work-related skills
- Activities that increase socialization and communication abilities
- Assistance with education and access to other community services
- Meaningful, paid employment in the community through employer business partnerships.

The Mental Health Crisis in Florida

More than 730,000 Florida residents live with serious and persistent mental illness, such as schizophrenia, bi-polar disorder, post-traumatic stress disorder, and major depression.

1 in 4 families are directly affected by these major psychiatric diseases.

Psychiatric illnesses comprise the **largest disability group** dependent on government benefits such as Social Security Disability, Medicare, and Medicaid.

Thousands are housed unnecessarily in prisons and jails throughout the state at a great cost to tax-payers, or are homeless, relying on the government for their most basic needs.

Consider this:

Florida ranks **50th** nationally in per capita expenditures on mental health services. The state has not kept up with the need or the real cost of these important services for Florida residents.

While the state population has grown by 2 million during the last 10 years, mental health funding has decreased, leaving many without access to proper treatment and support.

Unless the state increases funding for mental health services, the mental health crisis in Florida will continue to grow!

Clubhouses Work!

Research has shown that Clubhouse clients (called “members”) are 1/3 less likely to have crisis hospitalizations, 2½ times less likely to become incarcerated -- significantly reducing costs to taxpayers.^{1,2}

Clubhouse members are competitively employed in longer and higher paying positions than in more intensive work programs.³ Employment provides members with the ability to find dignity in their lives, and be less of a burden to the government.

Clubhouses represent a sound investment that benefits all Florida residents. Help us ensure that there is a Clubhouse available to every Florida community!
